Re: Renaissance Health Medical Aid Fund In-hospital Tariffs and Subsequent Collaborative Decisions

On the morning of the 29th of August 2023, before our meeting with MAN, the Trustees gathered and determined that the proposed decrease in in-hospital tariffs would be placed on hold. 
